Required Hardware, Operating System and other Requirements

Server/Individual PC – Single User

- 32 & 64-bit editions of Windows 8.1 Pro or Newer, Windows Server 2012 or newer
- Hard disk space: Minimum 2 GB
- Memory: Minimum 2 GB, more is better

Other Requirements

- High Speed Internet access – required for installation, support and assistance
- Backup device (external hard drive, CD/DVD writer or tape-backup)
- Printer – recommend 8.5 x 14 for printing Bound Book
- Must have Admin rights to local PC
- Subscription licensing requires unassisted Access to PC by BASM
